Mask Mandate Eliminated in City Facilities for Those Fully Vaccinated

Face coverings and physical distancing protocols are no longer required **in city facilities for those who are fully**

vaccinated. Those who are not fully vaccinated are still asked to follow these mitigation protocols.

This move is in accordance with <u>CDC guidance</u> and applies to both indoor and outdoor work spaces. This policy change applies to employees, contractors and customers or visitors to city facilities.

Note: The airport and public transit are still covered by the Federal mask mandate.


Community Input Needed on Draft Climate Action Plan

The City of Phoenix is currently working to update its Climate Action Plan, which will serve as a long-term plan to reduce greenhouse gas emissions from local operations and community activities as well as prepare for the impacts of climate change.

Renters Have Rights to Cool Air

With Phoenix experiencing temperatures upwards of 115 degrees, you should know Phoenix renters have a right to cool air!

Phoenix City Code Sec. 39-5 mandates cooling requirements for rental housing units:

"Every rental housing unit where such systems are installed shall have cooling capable of safely cooling all habitable rooms, bathrooms and

flushing toilet rooms to a temperature **no greater than 86 degrees Fahrenheit, if cooled by evaporative cooling, or 82 degrees Fahrenheit, if cooled by air conditioning**. Temperature measurements shall be taken at a distance three feet above the floor in the center of the room. Required cooling shall be provided by permanently installed cooling facilities."

Additionally, the city's ordinance also states that heating, cooling and ventilation systems in any building are to be maintained hazard-free, operational and in a state of good repair.


Dreamy Draw Park Closure

Please use the 22nd St. trailhead for Phoenix Mountains Preserve access. Water services will not be available at the Dreamy Draw Park facilities. "Take a Hike. Do it Right." Hiking Safety

City of Phoenix Park Rangers educate trail users to follow important <u>"Take a Hike. Do it Right."</u> safety guidelines. Regardless of the weather or time of year, always hydrate before, during and after a hike.



During Arizona's warm weather months, Phoenix Park Rangers and the Phoenix Fire Department recommend hiking during the early morning or evening hours when it is cooler and there is more shade.

Monitor the local forecast and understand that all <u>trail difficulty ratings</u> are raised one level when the temperature is 100 degrees or warmer.

Dogs are prohibited on all City of Phoenix hiking trails when the temperature is 100 degrees or warmer. Learn how to keep pets safe during warm weather months.

The <u>annual ban of open fires in Phoenix's desert parks and mountain preserves</u> went into effect May 1, 2021.

Hatcher Road Improvement Study

The Street Transportation Department is conducting a survey to gather community input and hear priorities for Hatcher Road. The survey is the first step in a project to propose streetscape improvements along Hatcher Road between 19th and Central avenues.

Update - Central Avenue Proposed Lane Changes Not Moving Forward



The City of Phoenix had proposed to adjust the motor vehicle travel lanes from two motor vehicle lanes in each direction to one motor vehicle lane in each direction with a center turn lane and buffered bicycle lanes in each direction. When a street is scheduled for pavement maintenance, it provides the opportunity to change the lane configuration (i.e., striping) to improve safety and add bicycle connectivity. Any time a proposal will adjust the number of motor vehicle travel lanes or restrict on-street parking, the city goes through a robust public input process.

Hundreds of residents attended a live virtual meeting, called the project hotline, emailed the project team, and thousands of residents took the online survey. As a result of the valuable public feedback, the Street Transportation Department is **no** longer pursing the proposed lane changes on Central Avenue, between Bethany Home Road and the Arizona Canal.

Street Pavement Maintenance



Street Transportation crews continue working hard around District 3 and citywide!

In District 3 alone, crews have completed 86.3 miles of mill and overlay work, 120 miles of preservation treatments, 137.7 miles of crack seal, and 2,028 ADA ramps (from July 1, 2018 to May 31, 2021).

This month, 23rd Ave. from Cactus Rd. to Dahlia Dr., and Dunlap Ave. from 7th

St. to 15th St. are scheduled for a mill and overlay treatment.
